# Board of Directors Eligibility & Requirements

1. The Kansas State USBC shall be divided into 12 regions. The regions shall be designated by number and the number of directors assigned to serve their respective local associations in each region.
2. There are 30 directors elected by the membership in staggered rotation as outlined in Article V of the Bylaws.
3. The term for directors is three (3) years with unlimited terms.
4. A maximum of three (3) bowling center proprietors may serve on the board at one time.
5. A candidate for the board (elected or appointed) must be:
  - a. A USBC member in good standing at the time of election and throughout their term.
  - b. Youth. USBC youth members bowling in USBC Leagues with the association's jurisdiction.
  - c. Individuals eighteen (18) years old and over must be compliant with RVP requirements prior to working with youth or within 45 days of the start of their term, whichever occurs first and throughout their term.
  - d. Elected or appointed without regard to race, color, religion, sex, sexual orientation, disability, national origin, or age, other than the minimum age of 14, unless state laws mandate a specific age, and be reasonably representative of the members.
6. Applications must be received by March 1st. Completed applications received after March 1st must be received at least 24 hours prior to the Annual Meeting to be eligible as a nomination from the floor.
7. Region directors must be a member of an association in the region they are applying for. (see table below)
